#### Editorial Code of Ethics

Editorial Code of Ethics of the Journal “Vestnik of Saint-Petersburg University. Series 13. Asian Studies. African Studies” provides the highest standards of cooperation between the authors, the Editorial Board of the Journal and reviewers within the publishing practice procedure. Editorial Code of Ethics is approved by the Editorial Board of the Journal and contains follows the guidelines of the Committee on Publication Ethics. The main purpose of Editorial Code of Ethics is to defend author’s intellectual property rights, to assure the required academic quality of the material published articles and to prevent wrongous unauthorized use of the submitted materials.

All participants of in publishing process (authors, reviewers, members of the Editorial Board, editors and staff of the Publishing House) are expected to adhere to the Editorial Code of Ethics.

#### **Code of Ethics for the Editor in Chief**

Editor in Chief bears full responsibility for the publishing of submitted materials. While making decision on accepting submitted material To accept an article for publication Editor in Chief must take into consideration evaluate its authenticity, scholarly competence and contribution, newness of information and originality, taking into due consideration reviewers’ opinion. of the article (in particular on the grounds of scientific review).

Editor in Chief’s should evaluate intellectual content of material and the quality of scientific outcomes, this evaluation should not be affected by the race, sex, sexual orientation, religion, nationality, social position, or political beliefs views (attitudes) of the authors.

Only the authors, reviewers, members of the Editorial Board, and the staff of Publishing House staff responsible for editing and publishing should gain may have access to the submitted materials.

All previously unpublished data which is presented by the papers in articles can not be used for private purposes or handed over to the third parties without written consent of the authors.

Intellectual information should be kept confidential during the whole process of editing, reviewing and publishing.

Editor in Chief should not accept for prevent publication any of the submitted material in cases of breach of scholarly ethics (plagiarism, reviewer’s suspected misconduct, or, for example etc.).

In his decision Editor in Chief should make his/her final decision in consideration of joint opinion also take into consideration the decision of the Editorial Board members.

Editor in Chief together in cooperation with the Publishing House of Saint-Petersburg State University should not ignore investigate all claims concerning submitted or published materials, and also take appropriate measures in case of conflict situation to settle conflicts.

#### **Code of Ethics for the Reviewers**

*The review of the submitted material should be objective:*

While estimating submitted material reviewer should pursue only academic objectives, avoid any tendentiousness and abide by following principles:

The Reviewer must refuse from making estimation if he/she lacks sufficient academic expertise in the field or in case there is a potential conflict of interests related to his/her professional or any other contacts with author(s), or companies and organizations being engaged in submission in one way or another. disclose any potential competing interests or incompetence on the subject before agreeing to review a submission.

The paper article should be regarded as a confidential document while under review; it should not be handed over to the third parties except for those who are authorized by the Editor in Chief or members of the Editorial Board.

The Reviewer should give objective and well-argumentative evaluation of the outcomes of the research presented in the paper article. Subjective Personal criticism on the author should be excluded.

Unpublished data gained from the reviewed paper article must not be used by the reviewer for his/her private purposes.

### **Code of Ethics for the Authors**

The Authors is are responsible for newness and authenticity of the outcomes of research and are strongly warned against presenting . The author(s) must not present deliberately purposely false or fabricated information data.

The Authors should guarantee the originality of submission submitted material. Quotation must be done in consideration of ethics and be obligatory All quotations must be duly accompanied with correct references. the details on the origin of citation. The Plagiarism in all its forms as well as excessive use of quotations is inappropriate completely unacceptable.

Contribution of any other individuals indirectly or partially involved somehow in the process of research should be declared. The paper Article must contain the references to all works anyway used by the author in research.

Authors should not submit the material that has been submitted offered to another journal or the material that has been already published.

Significant contribution of All other individuals who made significant contribution to the research presented in paper should are to be stated indicated (recognized) as co-authorship. The case Involvement of ghost or guest authors should will be regarded as misconduct.

Authors should immediately inform the editorial staff on as soon as possible in case there are essential mistakes or inaccuracies detected in the article whether during or after paper while editing or publishing.
