

# Impact of Income Inequality on the Rate of Economic Growth: an Approach to Modelling

A model of economic growth where subjective discount rates of consumers and the production function are formed endogenously is proposed. It is shown that the set of balanced growth equilibria is a continuum which can be parameterized by an index of inequality. Under some assumptions, the dependence of the balanced growth rate on this index has an inverted U-shaped form. Some empirical evidence supporting this form of dependence are provided.

- 1. Материал представляется в распечатанном и электронном виде. Объем статьи 0.5-0.7 авт. л. (1 авт. л. = 40~000 знаков, включая пробелы).
- 2. Печать должна быть выполнена с полуторным интервалом между строк, с полями: слева 2,5 см, справа 2 см, сверху 3 см, снизу 2,5 см. Шрифт Times New Roman 12 кг (12 pt).
- 3. Сноски на источники литературы, а также пояснительные вставляются автоматически в конце статьи (Меню Вставка Сноска Концевые (в конце документа) Вставить) и должны содержать выходные данные: фамилию, инициалы автора (ов) (выделяются курсивом), название работы, место, год издания, название журнала, том, номер, страницы. Разрешается использование электронных публикаций и Интернет-адресов с указанием всех данных.
